You represent and warrant that: (a) all of the important and central features and elements of the Materials are summarized in Exhibit A and that you have disclosed no other features or elements to AMI; (b) the Materials are wholly original, were created solely by you, are solely owned by you and no one else has any right, title or interest in the Materials (except as disclosed otherwise in Exhibit A); (c) no persons collaborated with you in creating the Materials (other than as disclosed in Exhibit A); and (d) you have the full right to submit the Materials to AMI upon the terms and conditions stated herein.
3. You believe the Materials and the features and elements contained therein are unique, original and novel. However, you acknowledge and agree that: (a) other persons (including AMI employees, independent contractors, licensees or third parties) may have submitted to AMI, or to others, or made public, or may hereafter originate and submit, or make public, similar or identical material which AMI may have the right to use; (b) the Materials may embody materials, suggestions or ideas substantially similar to those which have been developed by AMI’s employees, independent contractors or licensees, or which have been submitted to AMI by others; and (c) you will not be entitled to any compensation because of AMI’s use of such other similar or identical material.
4. You confirm that you have retained a copy of the Materials submitted to AMI and agree that AMI shall not have any obligation to return the Materials, or any responsibility, financial or otherwise, for loss or damage to the Materials. You authorize AMI to make such additional copies of the Materials as may be required for internal use in connection with AMI’s consideration of the Materials.

You hereby release and indemnify AMI from any and all liability, claims, and demands, causes of action, related to the Materials, including without limitation, claims and demands and causes of action related to unfair competition, copyright infringement, breach of implied contract and breach of confidentiality and for loss or damage to the Materials.

This Release is governed by the laws of the Province of Ontario and the parties irrevocably attorn to the exclusive jurisdiction of

the courts of the Province of Ontario and the federal courts located therein. Any reference to AMI shall be deemed also to refer to AMI’s subsidiary, parent and affiliated corporations, companies under common ownership or control with AMI, and each of their directors, officers, agents, employees, licensees, successors and assigns.
